### **ELECTED MEMBER RECOMMENDATION**

That Council REQUESTS that the Chief Executive Officer writes to the Chief Executive Officer of the Water Corporation to express Council's concerns regarding the five burst water mains that have occurred in the Shire townsite to date in 2024 resulting in service disruptions to residents and the delays in repairing associated infrastructure and seeking the Water Corporation's proposed response to ensure that service continuity and that Shire assets are protected into the future.

#### OFFICER COMMENT

A request for a Notice of Motion was received from Cr O'Brien on 19 March 2024. The Notice of Motion requests that the Chief Executive Officer write to the CEO of the Water Corporation regarding recent Water Corporation infrastructure failures that have resulted in property damage and service outages in the Shire.

Officers have identified five instances since the start of the year where burst water mains have occurred. These include three instances on Traverse St and one instance each on Tavistock and Ventor Streets. Full associated pavement and streetscape repairs following these burst water mains are in some cases still outstanding.

In a coincidence of timing, on Wednesday, 20 March 2024, the Chief Executive Officer received correspondence Water Corporation thanking the Shire for the support of the Shire in recent outages. The correspondence while a welcome appreciation of the Shire's efforts in this regard does not highlight the steps that Water Corporation is taking to ensure supply and repair to infrastructure when breaks do occur.
