#### **ELECTED MEMBER RECOMMENDATION**

#### **That Council:**

- 1. In accordance with Section 5.99 of the *Local Government Act 1995*DECIDES to pay an Annual Attendance Fee in lieu of council meeting, committee meeting and prescribed fees being
  - 48.8% of the maximum set by the Salaries and Allowances Tribunal for Councillors other than the President
  - 27.5% of the maximum set by the Salaries and Allowances Tribunal for the President
- 2. In accordance with section 5.99A(1)(b) of the Act, RESOLVES that each Council Member is to receive 28.6% of the maximum allowance for Information Communications and Technology set by the Salaries and Allowances Tribunal
- 3. In accordance with section 5.98(5) of the Act, Council has resolved that the President and Deputy President are to receive 100% of the maximum allowance set by the Salaries and Allowances Tribunal under that section
- 4. NOTES that under this approach the total annual remuneration for each office of Council in 2025-26 would be
  - President \$29,500
  - Deputy President- \$11,817
  - Councillor \$6,200
- 5. REQUESTS that the Chief Executive Officer amend Council Policy C2 Councillors out of pocket expenses to reflect this resolution
- 6. RESOLVES that this resolution is to take effect from 1 July 2025

#### OFFICER COMMENT

A notice of motion was received from Cr West on 21 May 2025 with the intention of revising the value and form of elected member fees and allowances.

Cr West has proposed a model whereby each Councillor would receive an annual remuneration of \$6,200 and the President would receive \$29,500. These remuneration totals would be a combination of allowances.

Under the *Local Government Act 1995*, elected members are entitled to receive remuneration. The Act provides that local governments can decide to remunerate elected members either on a per meeting basis or pay an annual attendance fee lieu of meeting fees. The second option being an annual attendance fee is paid to an elected member regardless of how meetings they attend.

Meeting fees can only be paid for Ordinary Council Meetings, Meetings of formal committee under 5.8 of the Act or certain specific meetings named in the *Local Government (Administration) Regulations 1996*. Council forums and budget workshops for example do not attract meeting fees.

Previously, by convention and later by policy, Council has resolved that remuneration is to be provided on a per meeting basis. Council Policy C.2 provides that elected members are to receive 75 per cent of the maximum Council meeting fee set by the Salaries and Allowances Tribunal.

Council has resolved that the President and Deputy President are to receive 75 per cent of the maximum President and Deputy allowance set by the Salaries and Allowances Tribunal. This allowance reflects the additional work undertaken by those positions and is separate and additional to meeting fees or the annual attendance fee paid in lieu of meeting fees.

The remuneration to elected members as published according to legislation in the 2023-24 annual report is as follows:

With eleven Ordinary Council Meetings at \$202 per meeting (75% of the maximum); approximately three committee meetings at lower committee fee rate of \$101 and an average of two Special Council Meetings per year (\$202), the approximate yearly remuneration under the Council Meeting fees option being \$2,936 will always be less than the minimum annual attendance fee of \$4,020.

Achieving the total annual remuneration for each Office of Council involves manipulating the remuneration under each category within the Salaries and Allowances Tribunal bands.

In 2023-24, the total remuneration of seven elected members at the Shire of Wagin was \$50,080. Under the proposed approach this would increase to \$72,317.
