## Conditions of Ownership:

- 1. Dog Owners are reminded that dogs three months and over must be registered at all times. Council also requests that dog owners inform Council immediately of any change of ownership, the death of a dog, or change in address.
  - Failure to register a dog may result in a \$500 penalty under the Dog Act.
- 2. In addition to the dog registration number tag, each dog must also have a tag on which is inscribed with the owners name, address and telephone number.
- 3. To allow your dog to be registered under sterilised rates, at the time of registering your dog you must present a veterinarians certificate with this application.
- 4. The maximum number of dogs over the age of three months that can be kept on any premises is two. Exemptions can be given after a formal request to the Wagin Shire Council has been made.
- 5. Dog owners must provide means on their property to effectively confine their dog. Means for effectively confining the dog does not include tethering.
